Welcome to Information Bulletin No. 3 from the Organising Committee of *Tampa 2011* the IDBF World Dragon Boat Racing Championships, being held from 2 – 7 August 2011. Keep up-to-date by visiting the Championships website: <http://tampa2011.idbfworldchamps.com>.

**World Championship Racing will take place from 3 -7 August inclusive, with the Opening Ceremony on Tuesday 2 August 2011. Competing Teams for the WDBRC are expected to arrive in Tampa between Friday 29 July and Monday 1 August 2011.**

### **ON-LINE REGISTRATION SYSTEM (NAMED ENTRIES) and ACCREDITATION**

**All Teams are expected to use the online registration system.** Team Managers will be issued with a data base password, on application to <http://idbfworldchamps.com/Registration.php> and can then record the details of each Team Member and Official Supporters, IDBF Race Officials and IDBF Member's Delegates (name, team role, passport number, date of birth) directly into the World Champs database. Photographs and Declarations can also be entered on to the data base.

## 2. ACCOMMODATION: Use APPENDIX 1 - ACCOMMODATION INSTRUCTIONS

The **only** method for booking an official hotel is through the **Org Com Housing Bureau – see below.**

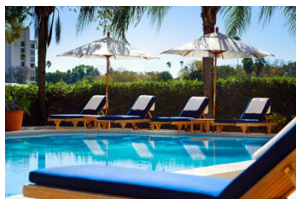
At Appendix 1 is the list of the 'Official Hotels' available during your stay. Rooms at special event rates are being held in hotels of different categories which are situated in Tampa City Center.

Rooms will be allocated on a first-come, first-served basis, thereafter they are subject to availability. Hotel rooms with breakfast can be reserved with the Org Com Package or separately.

**RACE COURSE HOTEL ROOM VIEWS - The Westin Harbour Island** is the only hotel that has views of the entire race course from its rooms. True to Westin style and ambiance, this hotel will be sure to impress, at a great price!



Double Double rooms, and King-bedded rooms are available from \$41.72 - \$166.88 per person with breakfast and taxes included. This rate allows for up to 4 persons sharing (2 beds) per room, with no additional fees.



Not only do the rooms overlook the race course, but so does the POOL! Just a 2 block walk (4 minutes) from the Athletes Village (Tampa Convention Center), you can be back at your hotel room, showered and watching the rest of the day's races, resting before dinner!

Please ensure that you make all bookings for the Official Hotels shown at Appendix 1, through the **Tampa 2011 Housing Bureau** at <http://tampa2011.idbfworldchamps.com/hotels/> and not directly with the hotels concerned.



### 3. **CELEBRATION DINNER: Use APPENDIX 2 - CELEBRATION DINNER RESERVATION FORM**

The Celebration Dinner on the evening of 7 August 2011 will be held at the Tampa Convention Center. Tickets include beverages, food and entertainment and will cost **USD 25.00, per person attending.**

Tickets can be purchased in advanced but payment must be received by the closing date for Named Entries. Tickets will also be available during the Championships at **USD 30.00, per person.**

The Official After Party of the World Championships will be held at [Channelside Bay Plaza](#) from 9 pm – midnight on Sunday, 7 August. This party is complimentary and all-inclusive for Paddlers, Supporters, Officials and Guests! Athletes will receive 1 complimentary drink in the Channelside Courtyard, where the live music will keep everyone celebrating into the night!



### 4. **RACING DAYS LUNCHES: Use APPENDIX 2 - RACE DAY LUNCHES RESERVATION FORM**

A buffet style lunch will be provided, in the Tampa Convention Centre on Racing Days (Wed 3 August to Sunday 7 August 2011), at a cost of **USD 8.00, per person, per day, for those Teams booking Official Hotels. Race Day Lunches may be purchased for Teams staying outside of the Official Hotels at a cost of USD 10.00, per person, per day. All Lunches must be pre-booked and paid for by the closing date for Named Entries.** Teams requiring lunches on training days should contact Tampa 2011 to discuss arrangements.

### 5. **ADMIN FEE - Use APPENDIX 2 TO CALCULATE ADMIN FEES**

An Admin Fee of 40 USD per person (discounted to USD 30.00 for Teams booking Official Hotels through the Tampa 2011 Organising Committee, is **payable to the Tampa 2011 Org Com** through Bank Transfer or by Credit Card to: <http://www.tampabaydragonboats.com/Default.aspx?tabid=68>.

Admin Fees are to be paid with the final Named Entries **NO LATER THAN 03 JULY.** Please use APPENDIX. 2 to calculate Admin Fees and for Race Day Lunches and Celebration Dinner Reservations.

### 6. **TRANSPORTATION: Use APPENDIX 3 – TRANSPORT BOOKING FORM**

**AIRPORT TRANSFERS:** Transfers from and to Tampa International Airport, will be provided by Tampa 2011, for Teams booking Official Hotels at no extra cost. Transport from Orlando Airport can be arranged at an additional cost. Teams must provide Tampa 2011 arrival and departure information no later than 4 July 2011 by using the Arrival and Departure Transport Booking Form at APPENDIX. 3.

**RACE VENUE:** Transportation to and from the Official Hotels to the Regatta Site at the Tampa Convention Center is not needed, as all are within walking distance. The furthest properties at 1.4 km (1 mile) from the Venue have complimentary shuttle services available.

**COSTS FOR TEAMS NOT TAKING THE OFFICIAL PACKAGE.** Transport to your hotel and the race venue is **NOT complimentary for Teams that do not stay at the Official World Championship Hotels** booked through the Org Com. Teams making their own Hotel arrangements will be required to book their own transport for airport transfers and any daily transport requirements to and from the race venue.

Airport transportation is approximately USD 22.00 return, per person. Tampa 2011 can arrange airport transport, through the Org Com Booking Agency, for Teams booking their own Hotels upon request and at a cost based on Team size - see APPENDIX 3. Teams making their own accommodation and transport arrangements will still be required to pay for all other services and the Championship Regatta Fees.



**7. TRAINING SESSIONS: - Use APPENDIX 4 TO BOOK TRAINING SESSIONS.**

Official water training is from Sunday, 31 July to Tuesday, 2 August 11. Inclusive, from 8 am – 4 pm. **Additional Training Sessions prior to Sunday, 31 July are available on a limited basis for 25 USD per 1 hour session.** Please indicate on the booking worksheet if you require additional practices.

**8. TEAM PROFILES:**

Teams will be able to submit a short (100 words max) team profile and a single photo for publication in the Souvenir Programme. **Text and photo can be submitted at any time up to Sunday, 4 July 2011.** Submissions must be sent via email to Christine Canevari, [ccanevari@tampabaydragonboats.com](mailto:ccanevari@tampabaydragonboats.com).

**9. IDBF REGISTRATION FEE & IDBF MEMBERSHIP - Use APPENDIX 6 and APPENDIX 7**

An IDBF REGISTRATION FEE of USD 15 per participant, is **payable by Bank Transfer directly to the IDBF, – see APPENDIX 6, with the Named Entry or on arrival in Tampa, at the very latest,** for every participant attending the World Championships. This includes official supporters as shown on the Final Named Entry Form. Payment details are included below.

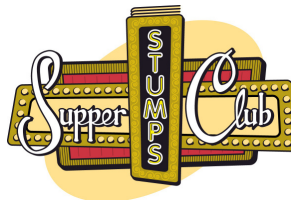


## CHAMPIONSHIP WEEK - EVENING ENTERTAINMENT PROGRAMME

## **TEAM MATTERS:**

### **REGATTA FEES:**

Regatta Fees, consisting of a Tampa 2011 Admin Fee and an IDBF Registration Fee, are compulsory for all participants, that is, competitors, team officials and accredited official supporters.

The payment of all Regatta Fees gives participants accreditation to the World Championships including access to the Boat Marshalling and Competitors Rest areas. Regatta Fees are quoted per person and valid throughout the whole championships. Payments are to be made through Appendix 2 for Admin Fees and Appendix 5 for Registration Fees.

### **12. NATIONAL FLAGS & ANTHEMS:**

Each team taking part in the 10<sup>th</sup> IDBF World Dragon Boat Racing Championship is asked to bring with them two (2) Official Representative Flags for their country or territory, of a size approximately 1m (6ft) x 0.5m (3ft). One flag will be utilized at the Opening Ceremony for the Parade of Nations, and the other will be utilized for Medals Ceremonies. Flags must be delivered to the Org Com Accreditation Room no later than Monday, 1 August 2011 at 5 pm.

**Please also provide an electronic file of your Country's or Territory's official anthem** to Christine Canevari, [ccanevari@tampabaydragonboats.com](mailto:ccanevari@tampabaydragonboats.com) by 4 July 2011. Preferred file types are .mpeg or .mp3, no larger than 5MB.



**TECHNICAL INFORMATION.** Full Technical Information will be published in **Info Bulletin 4** – Technical Bulletin but the following points are highlighted.

**13. DRUG TESTING:** Random drug testing will be conducted at the 2011 World Championships. Your attention is drawn to IDBF Regulation 11 concerning drug abuse and doping. All tests will therefore be set against the current IOC banned substances list and Members of the IDBF Medical and Sports Science Commission will be on hand to monitor the testing process.

The current List of Banned Substances is shown in the IDBF Anti Doping Policy – Annexes on the IDBF website: <http://www.idbf.org/>

**14. ENTRY CONDITIONS:** Entry to the IDBF World Championships is restricted to Teams selected and entered by their Member Associations' as a 'Representative Team'. As such the competitors race in Racing Colours of the country or territory that they represent.

**Team Racing Colours.** For IDBF Championships in which National Crews take part, IDBF Regulations state that competitors shall compete wearing their countries recognized national competitive colors that is to say the colours normally used by their National Olympic Association.

**1. Nationality.** The IDBF Nationality Regulation will apply (Competition Regulation No.4). Each Team may have up to a total of 84 Team Members (Standard Boats) or 48 Team members (Small Boats), in each Championship Division (Premier, U23s, Senior A and B and Junior A and B) to give a maximum Team total of 504 Standard or 288 Small Boat Team.

**2. Identification.** Each person on the Named Entry Form will be allocated a Personal Identity Number (PIN), which will be shown on the Accreditation Card issued to all participants on arrival in Tampa. Entry to the Regatta Site will be on production of the Accreditation Card.

**3. ID Checks.** Random ID checks will be carried out during the championships by the Race Officials to ensure that only those Competitors shown on the Named Team Entry List are competing.

**Crew Lists will also be checked** against Accreditation Cards by the Race Officials and Competitors will be selected for random Drug Testing by their PIN.

**15. EXCEPTIONS - BOAT HELMS, DRUMMERS AND U23s CREWS**

Teams are advised that IDBF Competition Regulation 2.12 excludes Male Helms from Steering in the Women's Racing Classes. The Drummer in a Senior Crew and the Helm (Steerer) in a Junior Crew do not need to conform to the relevant age limits shown below.

**Age Regulations: Senior A** – Age 40 or over, **Senior B** (Grand Dragons) – 50 or over as of 1 June 11

**Junior A** – Under 18 but 12 or over. **Junior B** – Under 16 but 12 or over as of 1 January 2011.

**U23 Crews.** Under 23 but 18 or over as of 1 January 2011 but up to 6 crew members below the age of 18, on 1 January 2011, may be included, in a Standard Boat Crew and up to 3 crew members in a Small Boat Crew.



**16. CREW LISTS:** A Crew List showing the competitors and reserves who will be racing in a particular Competition Class must be submitted by the Team Leader or Crew Manager to the Chief Official no later than 1 hour before the first race on the day in which the competition takes place. **(Examples are available for completion on the IDBF Data Base and a template for downloading, will be included in the Technical Information Bulletin – Bulletin Number 4. Fit To Race.** You are reminded that when signing the Crew List, the person signing is confirming with the Chief Official that all the competitors shown on the list are fit to Race.

This statement covers not just the physical ability of the competitors to undertake the race concerned but it also means that the signatory is confirming that there are no known medical reasons why those listed should not compete during the whole period of the Championships.

**17. DOUBLE ROSTERING:**

Teams are advised that whilst it is possible under the IDBF Competition Regulations for competitors to race in more than one Racing Class, for example, Women or Open and Mixed or indeed to race in both a Premier and or Senior/ Junior Division, with the exception of competitors in the Mixed Competition Classes, this form of 'Double Rostering' is not encouraged.

The reasons for this are two fold. The first is to give competitors adequate rest between their races. The IDBF Comp Regs allow for rest periods between races in the same Competition Class (40 minutes in the 500m competitions, for example) but if paddlers are in more than one competition class, then this regulation can become ineffective.

The second is that to enable all the Competition Classes on one day to be completed in good time, the Race Programme is constructed (with the exception of the Mixed Races) on the basis that competitors are only racing in one competition. When competitors race in more than one, the Race Organizers cannot guarantee that paddlers will not be in 'back to back' races during their racing day. Back to back racing is undesirable to all concerned.

Team Leaders are advised that no allowance will be made in the Race Programme for any competitors who are double rostered, with the exception of the Mixed Classes. Crews with double rostered paddlers are advised that in the event of 'back to back' racing arising that the Race Officials will not delay races or make any extra time allowances.

**18. RACING VEST NUMBERS:** Teams should provide their own sets of Racing Vest Numbers (1-26) but a limited sets of Racing Numbers will be provided by the Organising Committee by request and on a pre event order. Team Managers will be able to collect the Racing Numbers for each of their Crew when they attend Team Registration. **Please contact Christine Canevari [ccanevari@tampabaydragonboats.com](mailto:ccanevari@tampabaydragonboats.com) no later than 11 July to order Racing Numbers.**

**19. BOAT POOL:** All Teams are advised that only those dragon boats provided by the Organising Committee will be permitted to race in the Championships. For this World Championships a pool of twenty (24) Dragon Boats built to the IDBF International Standard Racing Dragon Boat Specification (ISRDB) will be provided in sets of six (6) or 4 boats per set, depending on the Competition Division and entries per Racing Class.



- 20. BOAT ALLOCATION** : Crews will be allocated to boats in accordance with the Lane Draws shown in the IDBF Tail Race Plans. Crews will NOT be allowed to pre-select a boat for any race or to race in a boat not provided by the Organizers.
- 21. COMPETITORS PADDLES**: Only IDBF Licensed Paddles showing the Spec 202a Manufacturers Mark will be permitted at the 2009 World Dragon Boat Racing Championships. Competitors not in possession of a Spec 202a paddle will be required to either borrow one from another competitor or purchase one before racing. **Please ensure that all paddles clearly display the IDBF License Number on them. See Important Notice to Team Leaders on page 13.**
- 22. SEAT PADS**. IDBF Competition Reg 13.1 Seat Pads. Dragon Boat Seat Pads (cushions) shall be made of a soft material, such as neoprene, of a maximum thickness of 15mm that will compress easily when squeezed between finger and thumb. The width of the seat pad shall approximate to the width of a paddling seat in the IDBF Standard International Racing Boat (12.5 cm) and the length should ideally, not exceed 33cm. **So seat pads should be rectangular, we will not be measuring seat pads to the exact cm, but obviously the round seat pads (IKEA type, for example) will not be accepted, unless they are 'cut to size'.**
- 23. SAFETY ISSUES: Boat Swamping or Capsize**. A capsized boat is rare in our World Championships but your teams must be trained and understand the recommended procedures in the event of a capsized boat. Full details of the IDBF recommendations can be found at: [http://www.idbf.org/documents\\_safety.php](http://www.idbf.org/documents_safety.php) It is essential that all teams are familiar with the "Buddy System" and that if a capsized boat should occur the paddlers are required to stay with the dragon boat and wait for the instructions for the safety boat crew. No one should swim to the shore.
- 24. START VIDEO AND PHOTO FINISH**: A fixed video camera will be placed in the Starting area which will record all Starts and assist the Race Officials in determining that Drummers are complying correctly with the starting instructions. This camera will also be used to help identify false starts. A fixed photo finish camera will be used at the Finish to record all boats crossing the finish line.
- 25. TEAM ACCREDITATION**: Team Accreditation will take place in the Tampa Convention Center, at the Regatta Site from 9am-4pm, Sat 30 July to -Tue, 2 August 2011. Team Registration is to be conducted by the Country Team Manager. Team Managers will collect ID Tags, Welcome Bags, Team Managers Information Package, etc. Team Managers can settle outstanding accounts and submit, flags, relevant declarations, waivers, etc at this time.

that is itself a Member of the International Dragon Boat Federation (IDBF). I certify that I am aware of the content of the Statutes, Bye-Laws, Competition Regulations, Rules of Racing and other rules regulating the International Dragon Boat Federation (IDBF) and Dragon Boat Sport

2. I am thus able to confirm the following commitments, which ensue from my membership of a club, team or crew affiliated to a DBO, which is itself a member of the IDBF and from my participation in IDBF activities, notably World Championships, international regattas, or other events which are organised under the authority of the IDBF or one of its Continental or Regional Federations, such as the Asian Dragon Boat Federation (ADBF) or European Dragon Boat Federation (EDBF).
